Payments renew automatically until cancelled.
All prices are in USD unless otherwise stated.

Any applicable taxes or processing fees are the responsibility of the member.

3. Cancellation Policy

- Members may cancel at any time via their account on the Canine Health Hub website.
- Cancellations apply to the next billing cycle.
- No partial refunds are provided for unused time in the current billing period.
- When a membership is cancelled, access remains active until the end of the paid period.

- Access to all content is granted while your membership is active.
- Membership content is for personal use only.
- Members may not copy, share, distribute, or sell any materials, videos, guides, templates, or training resources.
